Village Council Meeting was held 8/20/21 at 5:30pm at the Elizabeth Community Center, 210 East Main Street, Elizabeth, LA.

The notice of Meeting/ Agenda having been duly posted in accordance with requirements and a quorum being present, the meeting was called to order Mayor Mandy Green at 5:30pm. Prayer led by Ken Kelly-Mayor ProTem, then Pledge of Allegiance.

- 1. Mayor Green asked if there is any member of the public wishing to make comments regarding any item on the agenda. No comments from the public.
- 2. APPROVAL OF MINUTES
 - A. Ken Kelly made a motion to approve minutes from 7/27/21 meeting. Angela Smith seconded. All in favor.
 - B. Mayor request to remove the 2016 Kubota Mower as surplus property from the agenda.
 - C. Alderwoman Angela Smith made a motion to approve the agenda with change. Alderman Ken Kelly seconded. All in favor.
- 3. MAYOR'S REPORT
 - *Old Business
 - A. Public hearing opened on proposed Ordinance 26A Amendment to Ordinance 26 Zoning and Regulations. Comments made were that trailers-mobile homes that are present will be considered grandfathered in, but no new owner can live there after owner dies or decides to sell. The mobile home will have to be moved. Another mobile home can not be placed on property in all zoning districts except the Sunny Acres District A-2 in which a renter may be allowed. District A-3 which applies to Beech, Hickory and Bay Streets, mobile homes will be allowed with no renters. It was discussed in the new zone A-3 (owner or a family member occupancy only) that current renters will be allowed to stay, but upon moving, another renter will not be allowed. Mayor Green stated with notices and the new ordinance will be mailed to mobile home owners informing them of the new zoning upon approval. Mayor stated Donna McIntosh will be hired to enforce the zoning ordinance. She will be commissioned by Chief Ford to enforce it. Public hearing closed.

 - C. Public Hearing opened on proposed **Ordinance 33-21 Garage Sale Permits** which regulates how often and when garage sales, yard sales and such may be conducted in the Village Limits. Comments made were a request for no charge for the permits and to allow for 4 permits per year- 1 each quarter. Public hearing closed.
