

ORDINANCE NUMBER 3-95
TOWN OF ELIZABETH, LOUISIANA

AN ORDINANCE DESIGNATING NUMBERS FOR ALL LOTS, BUILDINGS, AND STRUCTURES WITHIN THE CORPORATE LIMITS OF THE TOWN OF ELIZABETH, ESTABLISHING THE SIZE OF SAID NUMBERS AND THE LOCATION THEREOF ON BUILDINGS AND STRUCTURES AND PROVIDING FOR A PENALTY FOR FAILURE TO POST NUMBERS.

BE IT ORDAINED, by the mayor and the Board of Aldermen of the Town of Elizabeth, Louisiana, that the Code of Ordinances, Town of Elizabeth, is hereby adopting Ordinance No. 3-95 to read as follows:

SECTION 1: NUMBERS REQUIRED All lots, buildings and structures within the corporate limits of the Town of Elizabeth, Louisiana shall be numbered in accordance with the following sections:

SECTION 2: CHART The Allen Parish Communications District has prepared a chart showing the proper street number for all locations within the Town, said chart conforming to the requirements of the E911 system to be operated by Allen Parish Communications District, and which chart shall be kept by the Town Clerk who will make the chart available and open for inspection by any interested persons.

SECTION 3: NUMBERS ON BUILDINGS AND STRUCTURES It shall be the duty of the owner or occupant of every house, building or structure in the Town to have placed thereon, in a visible place from the street, figures at least 2 1/2 inches high, showing the number of the house, building or structure; and, any person, firm or corporation failing to so number any house, building or structure owned or occupied by him, or if after receiving notice to do so from the Town Clerk shall continue in his failure to so number such house, building or structure, shall be fined \$3.00 for each day during which a failure to so number continues and in addition may be punished in accordance with Section 1-9 of the Code of Ordinances.

Notice of the proposal of the above Ordinance was published in the official journal on the 30th day of June, 1995.

Motion was made by Ken Kelly and seconded by Michael Melder to adopt said Ordinance.

The above and foregoing Ordinance was called for a vote by the Mayor at the regular meeting of the Town of Elizabeth, Louisiana held on the 6th day of July, 1995, and the vote thereon was as follows:
